

# 4.0 COMMENTS AND COORDINATION

This chapter includes a summary of agency coordination, public and stakeholder involvement, and tribal coordination that has occurred during the development of the EA.

# 4.1 Agency Coordination

During project initiation, FHWA and KDOT, acting as Federal and State lead agencies respectively, identified Federal, State, Tribal, Regional, and Local government agencies that may have an interest in the project to serve as participating agencies. The full list of identified agencies invited to coordinate is listed in the Project Coordination Plan in **Appendix I**.

#### 4.1.1 Initial Coordination Packet

KDOT, in coordination with FHWA, prepared an initial coordination packet for distribution to officials and agencies at the initiation of the EA. This packet included a letter inviting the agency to coordinate on the project, a project description detailing the project and a project study area map. **Appendix I** contains copies of the invitation letters to participating agencies, which were included in the initial coordination packet sent November 2, 2020. **Table 4-1** shows the invited Participating Agencies for the project and the date of response to the invitation. Coordination with Native American Tribes is detailed in Section 4.3.

The study team conducted a virtual Scoping Meeting with resource agencies on December 2, 2020 to overview the project and get early input on project social, economic and environmental constraints. In addition to KDOT and FHWA, representatives from the U.S. Fish and Wildlife Service and the Mid-America Regional Council attended the project Scoping Meeting.

### 4.1.2 Purpose and Need and Alternatives Analysis Agency Coordination

In addition to the Initial Agency Coordination outreach, two additional opportunities were provided for agencies to comment. Letters asking for comment on the purpose and need were sent February 1, 2021, and letters for the alternatives analysis, screening and selection were sent on October 4, 2021. The agencies contacted include those who responded to the Initial Agency Coordination and/or the purpose and need request and indicated a desire to participate throughout the EA process. # 4.2 Stakeholder Engagement

#### 4.2.1 Overview

The goal of stakeholder engagement for the U.S. 69 Modernization and Expansion Project was to inform the public on the project and provide regular updates, receive feedback, and collect and review comments about concerns regarding the improvements proposed for U.S. 69. To accomplish the stakeholder engagement goals of the project, the project team performed the following tasks:

- Created and implemented a Project Communications Plan (Appendix J);
- Developed and implemented a project website, project specific <u>Facebook</u> and <u>Twitter</u> pages as well as utilized KDOT's <u>Next Door</u> page;
- Organized and conducted Advisory Group meetings;
- Provided engagement opportunities and places to comment via a project email and comment submission form on the project's website (https://www.69express.org/);
- Held four rounds of Virtual Public Meetings and Virtual Public Open Houses;
- Sent out regular electronic project newsletters;
- Gave community presentations to organizations in Overland Park and nearby communities; and
- Conducted surveys and focus groups to understand how people see the future of U.S. 69 and how they would use the roadway if Express Toll Lanes (ETLs) were implemented.
- Formation of a toll equity advisory group to provide input on potential strategies for mitigating the economic impacts of tolling on EJ populations and to better understand what types of toll equity programs, transit, rideshare, or other project enhancements would provide meaningful benefits to EJ populations that rely upon U.S. 69 for their access to jobs or other opportunities.

#### 4.2.2 Public Meetings

As part of the ongoing NEPA process, three opportunities for the public to view project progress and to provide input on the project were provided. With health and safety in mind, each of these Public Information Meetings and Informational Open Houses were held virtually with a "live" component so that the public could ask questions of the project team in real-time. Due to COVID restrictions in-person options were not offered for Public Meetings #1 and #2. An in-person option will be offered for Public Meeting #3 if allowed by COVID-19 regulations. All participants attending the meetings were asked to sign in through a Public Involvement Management Application (PIMA) system established for the project. Each meeting had a specific focus, which is described in the following sections for each meeting.



All meetings and open houses were recorded and posted to the project website so that participants could review during their preferred timeframe. In addition to those that attended and signed into the live component of the Virtual Public Meetings and Virtual Informational Open Houses, more than 1,750 people also signed up to receive newsletters and updates about the project.

#### *4.2.2.1 Public Meeting #1*

The first Public Meeting was held Wednesday, January 20, 2021, from 4:30 p.m. to 6:30 p.m. in a virtual format via KDOT's Public Information Management Application (PIMA) website. The meeting started with a presentation from the project team that covered the project background, the proposed purpose and need of the project, the new Kansas tolling legislation, the 2020 U.S. 69 pre-planning analysis findings, as well as an overview of the environmental process and the stakeholder engagement process.

Two-hundred nine (209) people signed into the meeting using the PIMA site. Meeting participants then were able to ask questions and provide input to the project team by submitting a question or comment on the meeting website. These questions were read aloud and answered by the project team during the live portion of the meeting. Additional questions requiring follow-up were later responded to and sent to the individuals who inquired directly.

The Virtual Informational Open House was held January 18, 2021 – February 1, 2021, also through PIMA, and posted to the project website. Four-hundred forty-three (443) participants signed in over the course of two weeks. The Virtual Open House used a story map approach to convey information about the U.S. 69 Modernization and Expansion Project. The interactive meeting allowed participants to leave comments about the Project though a comment form. In the comment form, participants could place markers on a map to indicate where they have specific concerns, such as congestion or safety issues, along the corridor.

#### *4.2.2.2 Public Meeting #2*

The second Public Informational Meeting was held Tuesday, April 20, 2021 from 5:00 p.m. to 7:00 p.m. in a virtual format via KDOT's PIMA website. The project team's presentation covered the alternatives being considered for improving U.S. 69, the environmental screening process for alternatives, a comparison between traditional widening (toll-free) and express toll lane (ETL) build alternatives, ETL pricing, and the stakeholder engagement process. Two-hundred thirty (230) participants signed into the meeting.

The second Virtual Informational Open House was held from April 16, 2021 - April 30, 2021, also hosted through PIMA. Two-hundred fourteen (214) participants signed in



over the course of two weeks. Similar procedures as described in Section 4.3.2.1 were followed for both the Public Meeting and Open House and included both a live portion and an online story map that participants could review during the two week period.

#### *4.2.2.3 Public Meeting #3*

The final Public Informational Meeting was held on Wednesday, December 8, 2021 from 5:30 p.m. to 7:30 p.m. via KDOT's PIMA website. One hundred sixty-three (163) participants signed into the meeting. The meeting centered around presentation of the Draft EA document for public and agency review and comment, including the proposed Preferred Alternative recommendation, key findings and impacts of alternatives, 4(f) impacts, equity information, and summarized public feedback. Also highlighted was the 30-day public comment period beginning when the Draft EA was signed by FHWA and KDOT and posted for public and agency review. The public comment period for the Draft EA ended on January 22, 2022.

Similar procedures as described in Section 4.2.2 were followed for the Public Informational Meeting and corresponding Open House. The final Public Meeting included a virtual Open House serving as an active platform for the public to interact virtually. Questions and comments on information shared at the final Public Meeting were facilitated by the Open House along with its online story map component.

#### 4.2.3 Advisory Group

An Advisory Group was created at the beginning of the EA process and consisted of 33business, civic, and religious leaders in the Overland Park area that represent the community. The goal of the Advisory Group was for the project team to gain insight and feedback on the project. The Advisory Group established in the Fall 2020 was comprised of the members shown in **Table 4-4**.

Each of the seven Advisory Group meetings were held virtually. The first meeting was held in Dec. 2020 and overviewed the project and its purpose and goals. Subsequent meetings were held January 2021 through November 2021 and covered all topics from the public meetings, as summarized in the list below. Meeting summaries and recordings for all Advisory Group meetings were posted to the project website.

- Meeting 1: Project purpose and need; overview of Public Meeting #1.
- Meeting 2: Project concepts and costs.
- Meeting 3: Express toll lane (ETL) alternatives and implications.
- **Meeting 4**: Preferred roadway configurations and potential impacts/considerations.
- **Meeting 5**: Preliminary traffic and revenue estimates for ETL alternatives.
- **Meeting 6**: Final traffic and revenue estimates; recommendations to City of Overland Park City Council.
- Meeting 7: Review proposed project scope, cost, funding, schedule and construction.

### 4.2.4 Community Surveys and Focus Groups

ETC Institute was contracted by KDOT to conduct two community surveys. For each, a survey packet containing a cover letter, a copy of the survey, and a postage-paid return envelope was sent to a random sample of households in eastern Johnson and Miami Counties. Residents who received the survey were also given the option of completing it online or via a follow up phone call. The first survey was administered in November 2020 and completed by 1,270 residents. The second survey was administered in May 2021 and completed by 1,257 residents. Both surveys exceeded the goal of 800 participant responses. Complete reports with the survey results can be found in **Appendix K**.

ETC Institute also conducted two sets of focus groups to gather additional information around perceptions of U.S. 69 improvements and potential tolling solutions. The first focus group was conducted in January 2021 and the second in May 2021. Both sets of focus groups were conducted via Zoom meetings. A detailed breakdown of focus groups demographics and findings are provided in **Appendix K**.

January 2021 focus groups had seven sessions with 76 participants; 54 from Overland Park, 10 from Miami County, and 12 from other parts of Johnson County.

Topics for the January meeting included:

- Usage and general perceptions of U.S. 69
- Perceptions of driver safety in the study area corridor
- Perceptions of traffic flow throughout the corridor



- Awareness of and/or willingness to believe information about U.S. 69
- Importance of improvements to U.S. 69
- Top priorities for improvement to the corridor
- Tradeoffs respondents were willing to accept in relation to cost/construction timelines
- Familiarity with ETLs
- Support for using ETLs to help fund improvements to U.S. 69

May 2021 focus groups had seven sessions with 60 participants. Focus groups consisted of 42 participants from Overland Park and 18 from Miami County and Johnson County areas outside of Overland Park with demographic attributes reflecting the Project Study Area. May focus groups covered five broad topic areas outlined below:

- Usage and General Perceptions of U.S. 69 Corridor
- Reactions to Two Options for Making Improvements to U.S. 69
- Introduction to ETLs and Potential Costs to Users
- Reactions to Local Contribution Funding Source Options
- Assessment of KDOT's Public Involvement Efforts for the U.S. 69 Improvements Project

## 4.2.5 Community Presentations

The project team presented to community organizations throughout the Overland Park area and region as requested. The purpose of the presentations was to provide information on the U.S. 69 improvement options and answer questions. Members of the public and community, civic or business organizations could request a community presentation by email, submitting a comment on the project website, or by filling out the 'Request a Presentation' form at the bottom of the project website. Twelve one-hour community presentations were given to the community. Reminders that presentations could be requested were given at all public and advisory group meetings. Presentations included:

#### 4.3 Tribal Coordination

Initial coordination with Native American Tribes in Johnson County was conducted as part of the project initiation in November 2020, this coordination is noted in section 4.1.1. During that initial project coordination, no responses were received from the identified Tribes. Additional coordination with Native American Tribes was conducted by KDOT on June 8, 2021 via consultation letter to get their input on the project, its EA process, and to initiate Section 106 Coordination for cultural and historical resources. General descriptions of the project location and modifications were provided along with notification of the 60-day comment period. A copy of the consultation letter sent by KDOT to Tribe representatives can be viewed in **Appendix G**. The Alternatives Analysis Memorandum was also shared with the Tribes for consideration and comment in October 2021. Notification of the Draft EA for comment was shared with the Tribes in December 2021. A copy of the letters and responses are included in **Appendix L**.

Tribes contacted in Johnson County, as well as any responses received, are noted in **Table 4-5**.

#### **Public Review of the Draft EA** 4.4

The Draft EA was made available for public review and comment during a 30-day review period between December 23, 2021 and January 22, 2022. Copies of the Draft EA were also distributed to participating agencies described in section 4.1.1. Notices of availability of the Draft EA were also sent to participating agencies, tribes and interested stakeholders.

#### **Comments and Responses on the Draft EA** 4.5

This section provides a summary of the public comments and the agency review responses on the Draft EA. Twenty-Six written public comments were received from 15 commenters that ranged from not in favor (3), less in favor (2), neutral (8), leaning in favor (1), and in favor (1) of the Preferred Alternative.

The comments received generally referred to temporary closures of Section 4(f) resources, noise impacts and noise walls, impacts to traffic patterns, traffic safety, and air quality. Comments received from the public as well as written responses can be viewed in **Appendix L**.



#### Agency Responses:

The following section provides the agency review comments received for the Draft EA. The agency comment period on the Draft EA ended on January 27, 2022.

The FAA had no comments on the Draft EA but reiterated the project would need to be checked through their online "Notice Criteria Tool" to determine if formal notice and review for airspace considerations would be required.

The DWR stated permitting will be required from the DWR Water Structures Program and that the Water Structures program looks forward to continued involvement as the project proceeds.

The KDWP stated that their review indicated "there will be no significant impacts to crucial wildlife habitats; therefore, no special mitigation measures are recommended. The project will not impact any public recreation areas, nor could we document any potential impacts to currently-listed threatened or endangered species or species in need of conservation. No Department of Wildlife and Parks permits or special authorizations will be needed if construction is started within one year, and no design changes are made in the project plans." KDWP also stated that if construction hasn't started within one year (Jan 3, 2023), or if design changes are made in the project plans, KDWP must be contacted to verify continued applicability of their finding. KDWP considers construction started when advertisements for bids are distributed.



The KSHS stated that they have concluded that no historic structures are situated within the area of potential effect. Since this is a design-build project, KSHS requests that any changes be submitted for their comment and review.
